

**SOUTH GLOUCESTERSHIRE COUNCIL**  
**(Various Roads, Various Wards - Pre Surface Dressing) (Temporary Prohibition of Use by Vehicles, Foot Passengers, Pedal Cycles and Equestrians) Order 2026**

Notice is hereby given that South Gloucestershire District Council in pursuance of the provisions of section 14 of the Road Traffic Regulation Act 1984 as amended intends to make an order the effect of which will be to:-

- a) close, temporarily, to vehicles the lengths of road specified in Schedule 1 to this notice; and
- b) close, temporarily, to vehicles, foot passengers, pedal cycles and equestrians the lengths of road specified in Schedule 2 to this notice.

This order is required for the following reason: in connection with the likelihood of danger to the public consequent upon pre surface dressing carriageway patching works. The order will be operative from 10 August 2026 for a maximum period of eighteen months. The restrictions however may not be implemented for the whole of the period but only when traffic signs are in position and only for so long as is necessitated by the works which are anticipated to be of **2 weeks** duration in respect of each location. See Schedule 3 for **alternative routes**.

**SCHEDULE 1**

1. **Greenways Road, Yate** - that length which extends from its junction with B4059 Goose Green Way to its junction with Church Road
2. **Greenways Road, Yate** - that length which extends from its junction with Rectory Close to its junction with Gravel Hill Road
3. **Gravel Hill Road, Yate** - that length which extends from its junction with Greenways Road to its junction with B4059 Goose Green Way
4. **Grovesend Road, Thornbury** - That length which extends for Gillingstool to its roundabout junction with Midland Way
5. **Gillingstool, Thornbury** - the entire length
6. **B4058 Wotton Road, Iron Acton** - the entire length

**SCHEDULE 2**

7. **Chase Hill, Inglestone Common** - that length which extends from its junction with Hillesley Road to Chase Lane
8. **Chase Lane, Inglestone Common** - that length which extends from Chase Hill to the Gloucestershire County Council Boundary.
9. **Latteridge Lane, Iron Acton and Latteridge** - the entire length
10. **Sodbury Lane, Codrington** - the entire length
11. **Gibbs Lane, Dodington** - the entire length
12. **Claypit Hill, Chipping Sodbury** - the entire length
13. **Dodington Road, Chipping Sodbury** - that length which extends from a point 80 metres south of its junction with Lilliput Avenue in a southerly direction to its junction with Claypit Hill
14. **Gorse Lane, Cold Ashton** - the entire length
15. **New Lane, Alveston** - the entire length
16. **Itchington Road, Tytherington** - that length which extends from its junction with Earthcott Road to its junction with Duck Street
